 - High Desert development meeting was held. Owens and Manole attended, but the concerns over too much development were of no concern
 - Attended "Coffee with a Cop" at McDonalds and it was a nice way to meet up with an officer.
 - Our President, Woody Owens, invited District Attorney Raul Torres to come speak with our neighborhood association for the June 20, 2017 meeting. He accepted! All neighbors of GHNA are welcome to come hear from our elected law enforcement official at the Dwyer Substation, 12700 Montgomery NE, Albuquerque, NM 87111

- GUEST SPEAKER: Jill Garcia, APD Crime Prevention Specialist: Materials handed out & discussed the Block Captain program
 - o 22 Neighbors attended this meeting
 - o Materials included "no soliciting: signs; Crime prevention pamphlets
 - o Ms. Garcia talked about many substation services, including prescription drug disposal, community information, signs and stands for slowing down traffic, etc. and report or traffic incident forms to fill out. They do NOT have dispatch equipment to provide an officer to report to a call, so using telephone on 242-cops or 911.
 - o Ms. Garcia is the contact to conduct "walk the block" programs for crime prevention issues where she will come out with your neighbors and walk down the street identifying obvious issues of concern leaving you vulnerable to burglary or other crimes, and some simple steps that can be taken to curb those noticed concerns. Call her at 768-2220 to arrange for a Walk the Block
 - Lt. Bret White is now acting commander while Cmdr. Rodgers is serving as interim Deputy Chief.
 - o Crime mapping: Last 90 days of our area
 - Residential Burglary numbers are quite LOW for our area. Hooray!
 - #1 was "fraud" or ID theft, which is probably capturing the GH Shopping Center incidents;
 - 6 auto burglaries in this area
 - When hiking, do not leave items in a vehicle parked near trailheads
 - Ms. Garcia is quite concerned about the growing numbers of guns and ammo being stolen out of vehicles, so park your cars INSIDE the garage and <u>lock up those magazines and</u> <u>weapons</u>. Leaving them in the car is a terrible idea, particularly for a non-garaged vehicle.
 - Auto theft is on the rise and of concern as well. Check the APD pamphlets for hints on avoidance of risk
 - GH Neighborhood has only TWO (2) active blocks in neighborhood watch 13400 block of Desert Hills Place and 4900 block of Glenwood Hills.
 - NO OTHER BLOCKS ARE ACTIVE NEIGHBORHOOD WATCH!!!!
 - Innovative ideas on crime prevention included HOA-sanctioned neighborhood cameras; advertising new homes for sale to our neighbors so you can "pick your neighbor"
 - o To form a neighborhood watch:
 - Contact APD Crime Prevention office 244-6644
 - Gather commitments from at least 50% of nearby homes
 - Host a meeting and identify a captain (or co-captains)
 - Get training and then be an active group!

• Treasurer's Report review and approval

- Month-end April finance report and prior 2017 reports are stored in the GHNA 2017 documents file (link in EMAIL). We ended the month of April with \$16,335 in total association cash. We gained 2 net new members. We are still at 43%. Peter working on new postcard mailing for the month. There may be additional checks to be deposited in PO Box and there have been five Pay Pal payments since our last meeting.
- BUDGET submission and approval The 2017 budget is saved <u>on the shared drive</u>. This same file contains the 2016 budget. There was no approved 2015 budget.
- Status on Audits Dave is working on these. Budget for 2015 (does not exist) and for 2016 (see above).
- Board Insurance status they declined our application so I went back to our original provider, The Walker Agency. Linda Walker is saying that in order to provide insurance, we need both General Liability for the association and also Board of Directors Liability. General Liability protects GHNA if someone gets hurt as a result of something they claim is GHNA's fault. Board insurance protects the board if we get sued by an association member for a DECISION we made. They are going to provide a quote for both policies.
